

# 75<sup>th</sup> Anniversary of The Universal Declaration of Human Rights

December 10, 2023 marks the 75<sup>th</sup> anniversary of the <u>Universal Declaration of Human Rights</u>, with the theme of 2023 being Dignity, Freedom, and Justice for All. The Declaration consists of 30 articles detailing an individual's basic rights and fundamental freedoms, and recognizing that all humans were born free and equal regardless of nationality, place of residence, sex, national or ethnic origin, color,



religion, language, or any other status. Article 25 states, "Everyone has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services." As service providers in DC, you bring Article 25, and many of the other articles, to life with the work you do.

## Friendly Reminder

We all know trainings sell out quickly, so to help your co-workers and colleagues complete their training requirements, please <u>cancel your registration if you can no longer attend a training</u>. On average, approximately 50% of TCP training registrants do not attend trainings.
