## Training Transcript Updates

Training Transcripts are used as a guideline for providers to know who must attend which trainings, and to keep track of trainings attended during the contract period. We strongly encourage all providers to compare their Training Transcript with their contract requirements. Training Transcripts are a general guide for all providers and programs, meaning they do not capture the nuances of each contract.

The TCP Training Team will continue to update the Topic Training Transcripts (found on our [website](#)) to reflect changes to our training program. However, those updates may not be reflected in your contract, meaning it would not apply to you. We recommend program leadership compare the Training Transcript with the program's contract when the contract is used. Leadership should save and use that transcript until a new contract or modification is issued.

## Training Intended Audience

The monthly training calendar lists some trainings as "Optional" and some trainings are as "Optional - [intended audience]." So, you may be wondering, what is the difference?

In program contracts, TCP *requires* housing providers to attend many of our trainings, while other trainings are marked optional, but strongly recommended. These trainings marked optional in contracts are listed in the training calendar and on Eventbrite as "Optional - [intended audience]." Other trainings which are labeled "Optional" in the training calendar and Eventbrite are special offerings that are not contractually required by TCP. These are the trainings that staff can elect to attend at their own discretion.

With all of that said, while trainings may be listed as "Optional" or "Optional - [intended audience]" on the training calendar, Eventbrite, or training transcripts, you should always verify your requirements with your employer and your program's contract with TCP. The TCP Training Team offers a wide variety of trainings and *all* trainings are strongly recommended.
