# **National Voter Registration Month**

In 2002, Secretaries of State established September as the National Voter Registration Month to encourage voter participation and

increase awareness of state requirements and deadlines for voting. This year, National Voter Registration Day is September 17th, and there will be registration locations throughout the District. By



going to <u>nationalvoterregistrationday.org</u>, you (or your clients) can check your voter registration and/or register to vote online!

As a reminder, when discussing voting and politics with clients, it is important to stay non-partisan and *provide information only* so your clients can make educated voting decisions. Explain the importance of voting and empower your clients to have their voices heard.

# **Training Topics**

Last year, the Training Team updated how we will be monitoring training requirements. Previously, requirements were monitored by the *title* of trainings staff attended. In July 2023, we updated the requirements so that staff must now attend trainings to cover a list of *topics*. Training Transcripts now list all required topics, leaving a column for staff to enter the title of the training they attended that covered the topic. The reason for this update was to combine training topics, reducing the overall number of required trainings, and to allow the Training Team more flexibility when updating trainings.

All training certificates list the topics covered in the training. Additionally, the TCP Training Course Catalogue found on <u>our website</u> lists the most recent offering of trainings and the training topics covered in the training. Furthermore, the September training calendar (and all calendars moving forward) will include which topics are covered by each training to, hopefully, make it easier to monitor and complete training requirements. ## **Hypothermia Season**

While we may still be trying to beat the heat, hypothermia season will be here before we know it. Hypothermia in Service training will begin in September, with the first in-person training taking place from 9am to 5pm on September 23, 2024 at the Hill Center (921 Pennsylvania Ave SE).

Hypothermia occurs when the body reaches a dangerously low body temperature, typically below 95 degrees Fahrenheit. During hypothermia season in DC, the shelter hotline is available 24/7 to assist with transportation to hypothermia shelters. Hypothermia shelters will be available from November 1, 2024 through March 31, 2025.

Low Barrier Shelters and security staff must attend the Hypothermia in Service training, which covers several important topics for working in a hypothermia shelter. **There will be 4 IN PERSON hypothermia trainings**, beginning in September, and everyone who does not attend an in-person training must complete the training on-demand.

Please note, spots for in-person training are limited, and we recommend new staff and security staff attend in-person, while returning staff complete the training ondemand. More information will be sent out very soon.
